- Currently employed full-time or part-time in an NSW high school

Participants who meet the following criteria will be excluded from the study:

- Currently teaching only Kindergarten Year 6
- Currently teaching outside of NSW
- Do not teach Creative Arts, English or Science

4. Do I have to take part in this research study?

5. What does participation in this research require, and are any risks involved?


If you agree to participate, you will be asked to complete the following research procedures.

You will be asked to complete this survey on one occasion. The survey should take approximately 40 minutes to complete. After you have completed the online survey, you will be asked if you would like to register your interest to participate in the Phase 2 Online Interviews. You will be asked to provide your contact details and be provided with a link to a copy of the Online Interview PISCF. You can consent to participate by providing your digital signature before exiting the online survey or by sending your signed interview PISCS form to the research team (see section 11 below).

Interview: If you provided consent after completing the online survey, you will be asked at a later date and time to participate in an online video interview where you will be asked questions about your

The interview will take approximately 40 minutes and will take place on Zoom. With your permission, the research team would like to record the interview in audio. If you do not wish to be recorded but would like to participate, advise the research team, and written notes will be taken.

Difficulty with Questions: You may feel that some of the questions we ask are difficult to answer. If you do not wish to answer a question, you may skip it and go to the next question or stop immediately. If you become upset as a result of your participation in the research project, the research team will be able to arrange for counselling or other appropriate support. Alternatively, the number for a free contactable support service is included in section 9. Any counselling or support will be provided by qualified staff who are not members of the research team. This counselling will be provided free of charge.

6. What are the possible benefits of participation?

We hope to use the information we get from this research study to develop a greater awareness and appreciation of the reality of assessment practices within NSW secondary classrooms compared to what is depicted in recent literature and assessment policy. This will provide the basis for clarifying and resolving the disjunction between assessment and pedagogy, which has been shown to compromise student learning.

7. What will happen to information about me?

You can withdraw your consent to share your data for future research purposes at any time by closing the questionnaire. See section 8 for further details.






